

**BYLAW 4:2011
VILLAGE OF FORESTBURG
PROVINCE OF ALBERTA**

A bylaw of the Village of Forestburg, in the Province of Alberta to amend Bylaw 3/2002, Bylaw 6/2003, Bylaw 1:2009 and Bylaw 1:2010 Water, Sewer and Garbage Rates Bylaw, pursuant to Section 7 and Section 8 of the Municipal Government Act, R.S.A. 2000 Chapter M-26, amendments thereto, Providing for a Bylaw Respecting Management and Conduct of Public Utilities.

WHEREAS, the Council of the Village of Forest may enact bylaws regulating the provision of public utility services rates;

WHEREAS, under the provisions of section 63 & 64 of the Municipal Government Act, being Chapter M-26.1, of the Revised Statutes of Alberta, 2000, and amendments thereto a Council may pass an amending Bylaw;

NOW THEREFORE, the Village of Forestburg Council enacts as follows:

SECTION 1. UTILITY RATES, be amended by revising the **Water Monthly Rate** for Residential/Commercial as follows:


Bylaw 1:2010 is hereby recinded.
