BYLAW 2:2023

VILLAGE OF FORESTBURG PROVINCE OF ALBERTA

A Bylaw to authorize the rates of taxation to be levied against assessable property within the Village of Forestburg for the 2023 taxation year.

WHEREAS, the Village of Forestburg has prepared and adopted detailed estimates of municipal revenue, expenses and expenditures as required, at the Council Meeting held on May 4, 2023; and

WHEREAS, the estimated municipal revenues from all sources other than property taxation total **\$2,958,287**.

WHEREAS, the estimated municipal expenses (excluding non-cash items) set out in the annual budget of the Village of Forestburg for 2022 total **\$3,898,487** the balance of **\$1,008,200** is to be raised by general municipal property taxation; and

WHEREAS, the estimated amount required to repay principal debt to be raised by general municipal taxation is **\$134,962**; and,

WHEREAS, the estimated amount required for current year capital expenditures to be raised by general municipal taxation is **\$54,884**; and,

WHEREAS, the estimated amount required for future financial plans to be raised by municipal taxation is **\$210,036**; and,

WHEREAS, the 2022 Village of Forestburg Audited Financial Statements identified an over levy of **\$2,864.53** for Residential School Tax and an over levy of **\$1,570.72** for non-residential School tax.

THEREFORE, the total amount to be raised by general municipal taxation is \$1,008,200; and,

WHEREAS, the requisitions are:

WHEREAS, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statues of Alberta 2000; and

WHEREAS, the assessed value of all property in the Village of Forestburg as shown on the assessment roll is:

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Village of Forestburg, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Forestburg:

- 2. The minimum amount payable per parcel as property tax for general municipal purposes shall be **\$900**.
- 3. All taxes shall be due and payable, without penalty, up to and including August 15, 2023. A penalty of ten percent (10%) shall be added to all unpaid current taxes on August 16, 2023.
- 4. A penalty of twelve percent (12%) shall be added to all unpaid taxes and costs on January 1, 2024.
- 5. Bylaw 5:2022 Tax Rate Bylaw is hereby rescinded.
- 6. This bylaw shall take effect on the date of the Third and Final reading.
